4 FIRST AID MEASURES

Eyes	Irrigate copiously with clean, fresh water for at least 15 minutes. Seek medical advice.

5 FIRE-FIGHTING MEASURES

6 ACCIDENTAL RELEASE MEASURES

Personal Precautions Eliminate all sources of ignition (cigarettes, flames, sparks, etc.) from the leakage site. If there are no contraindications, spray solid products with water to prevent the formation of dust. Use breathing equipment if fumes or powders are released into the air. Block the leakage if there is no hazard. Do not handle damaged containers or the leaked product before donning appropriate protective gear. Make sure the leakage site is well aired. Contaminated material should be disposed of in compliance with the provisions set forth in point 13.

Store in a well ventilated place, keeping the containers closed when not used. Do not smoke while handling. Keep far away from sources of heat, bright flames and sparks and other sources of ignition.

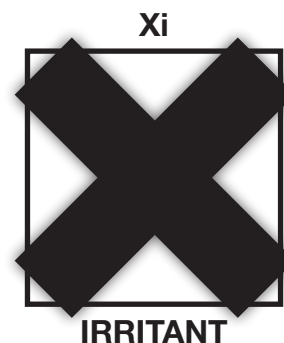
