4 FIRST AID MEASURES

Eyes	Wash immediately with plenty of water for at least 15 minutes and seek medical advice at once.

5 FIRE-FIGHTING MEASURES

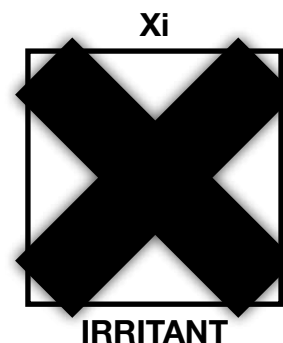
